RESOLUTION TO AWARD

WHEREAS, the Department of Social Welfare and Development Field Office VI will procure **Medical Supplies (Thermometer and Thermal Scanner)** for the use of **DSWD Staff** with the Approved Budget Cost in the amount **ONE HUNDRED FIFTY THOUSAND PESOS ONLY (Php 150,000.00)**;

WHEREAS, in accordance with RA 9184, Revised IRR Sec. 10 provides that as a general rule, all procurement shall be done in competitive bidding, except as provided in Rule XVI of this IRR regarding ALTERNATIVE METHODS OF PROCUREMENT. Thus, this procurement was done through ALTERNATIVE METHODS OF PROCUREMENT;

WHEREAS, quotations were submitted by **SUPER VALUE PHARMACY, MARX PHARMACY, BGC PHARMACY** and **RJQ SHIRT & GENERAL MERCHANDISE** wherein **SUPER VALUE PHARMACY**, has offered the lowest quotation in the amount of **FORTY-FOUR THOUSAND ONE HUNDRED PESOS ONLY (Php 44,100.00)**;

WHEREAS, upon checking of the documentary requirements it was found that **SUPER VALUE PHARMACY** and **MARX PHARMACY** have no PhilGeps Registration, hence, non-responsive to the mandatory requirements and considered disqualified;

WHEREAS, upon deliberation of BAC members, in the presence of the end user it was recommended that the procurement of **Medical Supplies (Thermometer and Thermal Scanner)** for the use of **DSWD Staff** will be awarded to **BGC PHARMACY**, the third lowest and responsive quotation in the amount of **FIFTY FIVE THOUSAND FOUR HUNDRED PESOS ONLY (Php 55, 400.00)**;

NOW THEREFORE, upon motion of **Ms. LUNA S. MOSCOSO** duly seconded by **Ms. FREDYLIN P. SACLOTE**, be it RESOLVE, AS IT IS HEREBY RESOLVED that the procurement of **Medical Supplies (Thermometer and Thermal Scanner)** for the use of **DSWD Staff** will be awarded to **BGC PHARMACY**;
